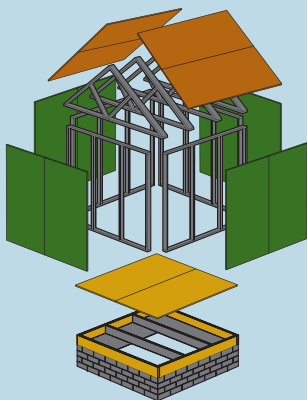

> Rebate and incentive payments will be issued within approximately 60 days of receipt of completed registration form and valid invoices.

**PARTICIPATION DETAILS**

- > Builder buys qualifying products for the first time from July 1, 2010 to December 31, 2010.
- > Submit completed registration form and invoice(s) showing Huber product purchase from July 1, 2010 to December 31, 2010 to the following address:
